## Global supply status and plan

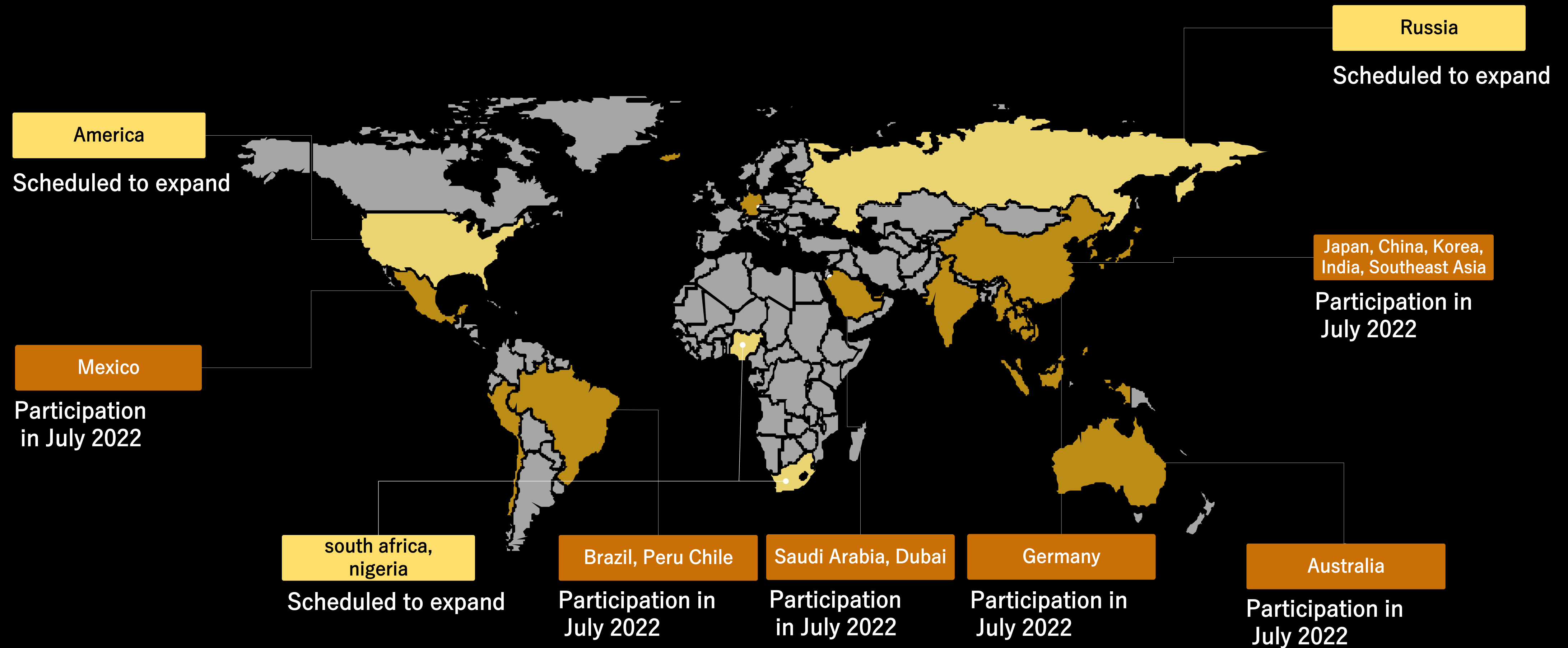
The W Community will be spreading to the following countries, starting with Germany, Dubai, Singapore, South Korea, Japan, India and the rest of the world

1W (100 USD) is the cost of participating in the community fee (voluntary donation and operating funds), and is also the number of eternal W issued.

The reason for immortality that never disappears is a great ideology and a system that never overpays

In order to advance into ourselves, the Earth, and the universe, a way of thinking based on the principles of finance or truth studies is the basis ”

1. When registering as a new member and leveling up, use W for the number of issued items!
  2. You can also exchange to another Coin at any time!
  3. Exchange to USDT is more convenient, and the W side fee is free!
  4. It can also be used for QR payments between communities and company managers!
  5. It also leads to the redistribution of human wealth and the development of other industries!

In the future, along with distribution activities, funds will be needed for system improvement and evolution of infrastructure such as platforms for W development and wallet withdrawals

This will continue to be carried out through voluntary donations and support contributions from community members

## **W Start Circumstances**

**The safety of the no-overpayment platform will be verified after a test period of approximately 6 months from July 30, 2022.**

**Participating countries include Germany, Dubai, Singapore, South Korea, Japan, India, Mexico, Brazil, China, and Southeast Asia.**

**More than 30 leaders participated in Japan as well.**

**System improvements and “highly efficient royalty system” will be reconsidered and restarted until March 2024.**



# Question & Answer

## Question 01

Q. Will W's network system be stopped in the future?

A. It cannot be possible. The reason is that the balance of funds is systematic and will never be broken because there are no Overpayments.

W is not a private enterprise state for profit approach. Even if not all tens of thousands of people in a community participate in supply activities, no special problems arise.  $1W = 100$  USDT, the number of distribution activities is issued. Because it is a financial concept of the original universe, it does not violate important human customs or international laws.

## Question 02

Q. When is W issued?

A. This is a time when a fully mobile Swap wallet will be able to build a fully automated, non-centralized network based on decentralized blockchain technology.

## Question 03

Q. What is W's finance?

A. We study barter, Coin, fiat currency, cryptocurrency, Uniswap wallet, exchange, banking, finance, financial concepts of the original universe, structure of the universe, world of ideas, eternity, and infinite world. It is also a school that develops financial markets.

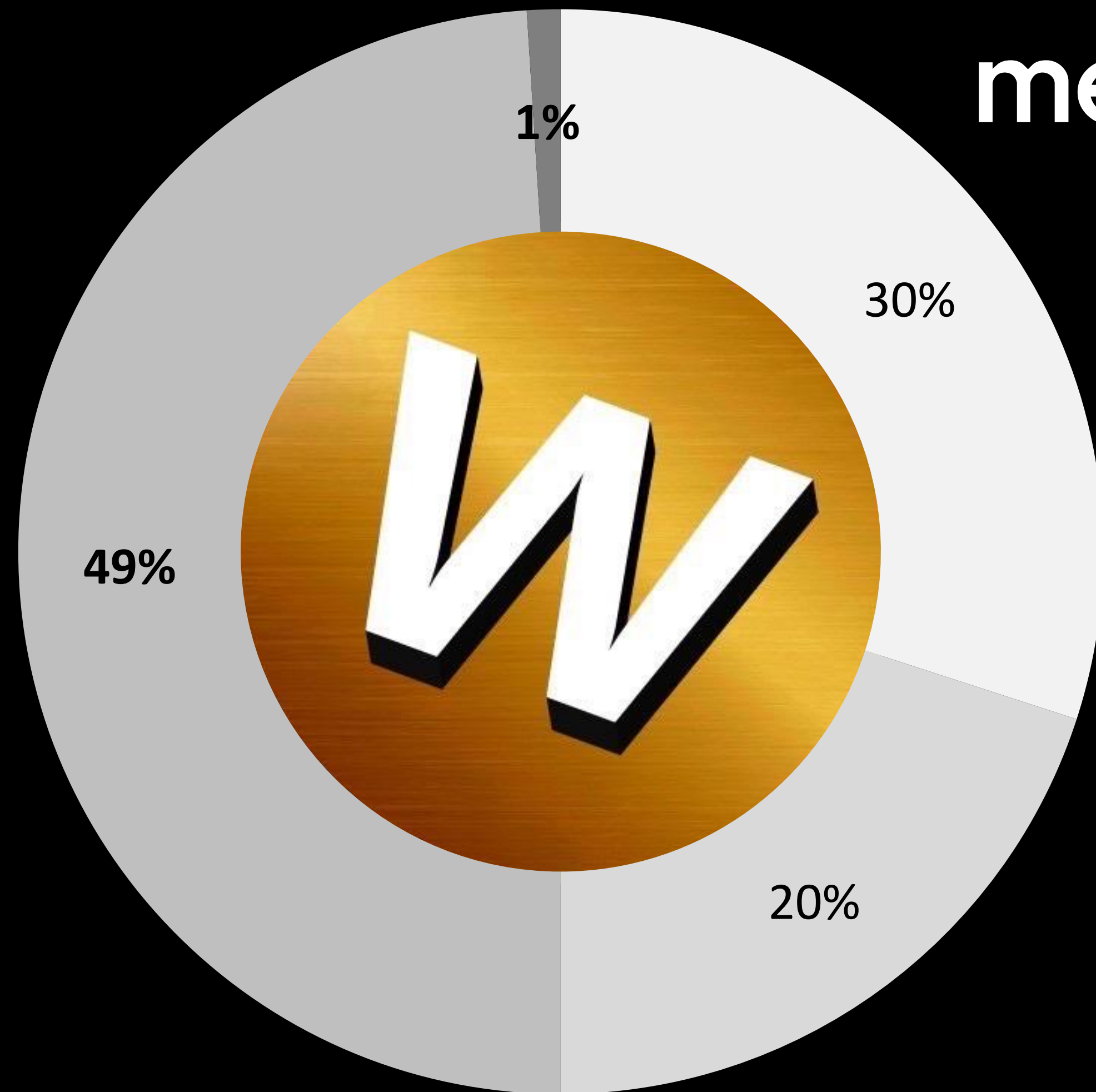
Everyone in the community is one another's students, teachers, and partners. As you innocently and happily travel around the world together, you will obtain many coins you never thought possible.

## DAO Level Distribution Percentage: Total 40%

Additional incentive conditions: 10W or more

- Level 1 (1L) acquisition rate: 20% When the total group total, excluding yourself, reaches 250W (\$25,000), you can receive 20% of the group performance as royalties from next day
- Level 2 (2L) acquisition rate: 30% When the total group total, excluding yourself, reaches 500W (\$50,000), you can receive 30% of the group performance as royalties from next day
- Level 3 (3L) acquisition rate: 35% When the total group total, excluding yourself, reaches 1,000W (\$100,000), you can receive 35% of the group performance as royalties from next day
- Level 4 (4L) acquisition rate: 40% When the total group total, excluding yourself, reaches 2,000W (\$200,000), you can receive 40% of the group performance as royalties from next day
- Level 5 (5L) acquisition rate: 45% When the total group total, excluding yourself, reaches 5,000W (\$500,000), you can receive 45% of the group performance as royalties from next day
- Level 6 (6L) acquisition rate: 48% When the total group total, excluding yourself, reaches 10,000W (\$1,000,000), you can receive 48% of the group performance as royalties from next day
- Level 7 (7L) acquisition rate: 49% When the total group total, excluding yourself, reaches 50,000W (\$5,000,000), you can receive 49% of the group performance as royalties from next day

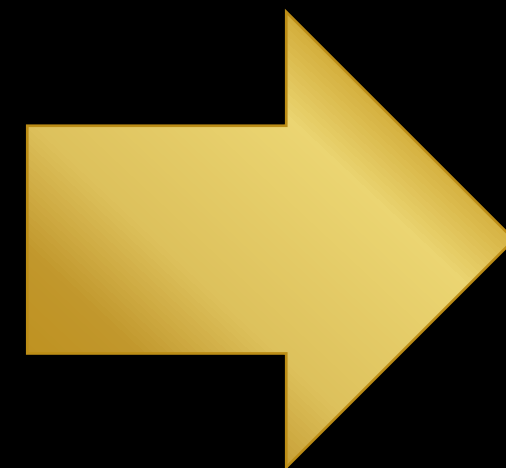

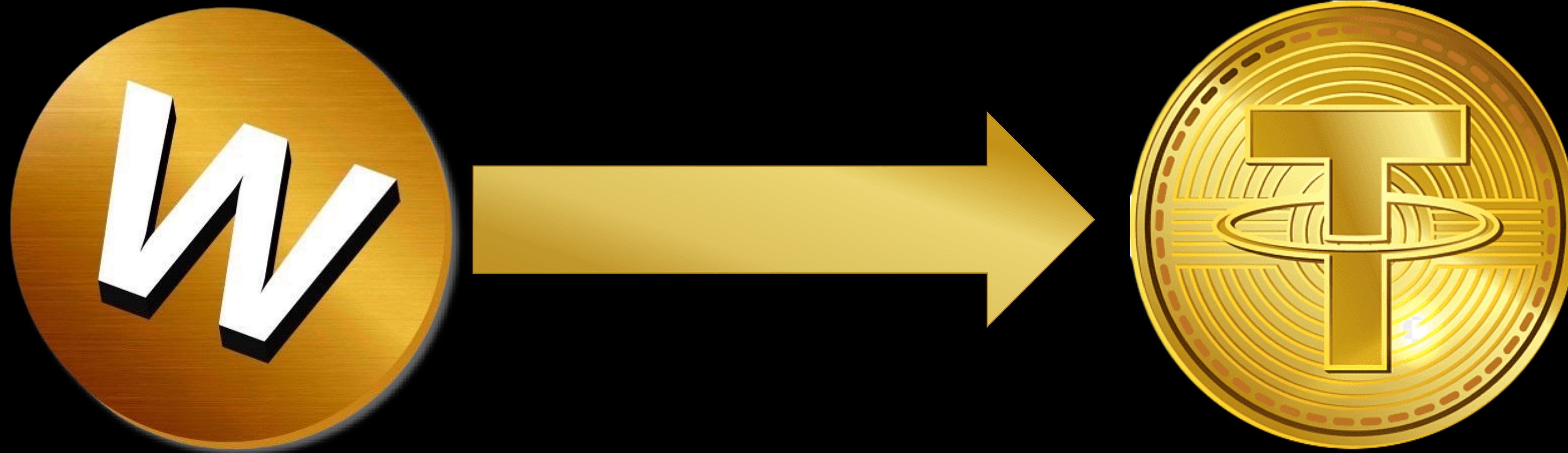

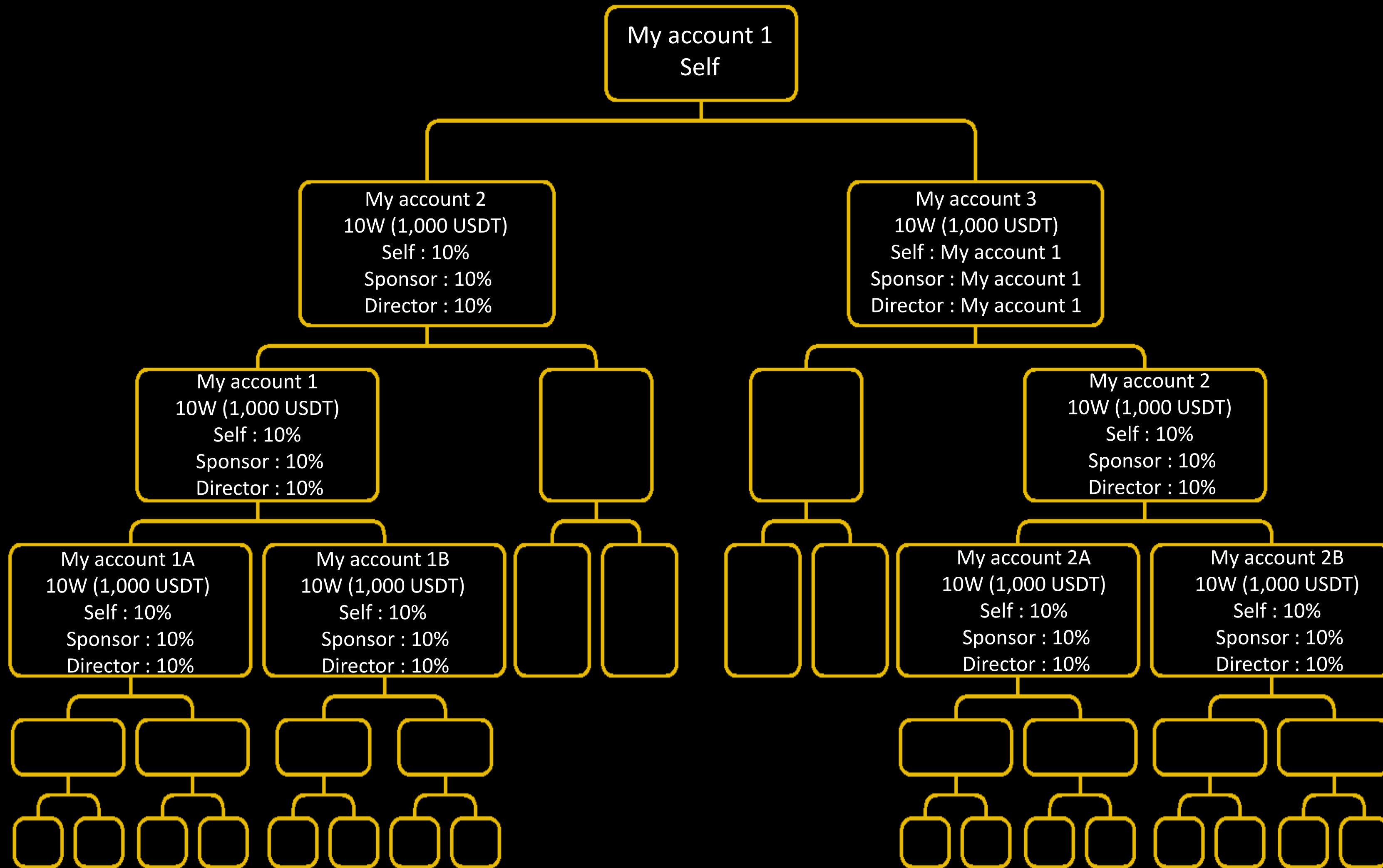

## Basic Principles

1. W is the DAO circulation method with 100% reduction .
2. Participation starts from 1W, one person per position, and the spread royalty is 1000% (10 times) of the participation fee If it exceeds it, you need to add more.
3. You can make direct introductions to up two people, and if someone achieves a level in those two lines, you can add one line Also, if there are achievers in a new line, the number can be increased one by one
4. If there is a person who achieves the same or higher level under you, you cannot receive level achievement royalties from that person The achiever can receive it

## Important

1. W is not a profit-seeking company or organization
2. W values transparency and can maintain a simple yet safe system
3. W is not overpaid
4. W's balance of funds is permanent



## 1. Unprecedented 100% (99%) reduction in DAO level circulation equation

- An unprecedented 99% (1% is for server and other administrative and maintenance costs) is distributed to participants as royalties
- Up to 55% of commissions can be earned separately as affiliate income through business partnerships with exchanges such as BingX

## 2. Decentralized autonomous organization with no overpayment management system

- The distribution ratio consists of 30% referral fee, 20% center fee, 40% DAO level achievement fee, 9% time deposit, and 1% server management and maintenance fee
- You will never overpay by more than 100%  
Nor will you pay less than 99%
- The system operates on a decentralized DAO basis, with system administration and services performed by professionals
- It is not a centralized, profit-oriented organization
- There is no operating company and no CEO There would be no dictator like a top leader
- Top community launched in 40 countries including Germany, Dubai, Singapore, South Korea, Japan and India and System developers, system administrators, and support personnel perform dissemination activities on the same level as community participants.
- Secure and permanent BlockChain decentralized system

### 3. A system focused on transparency and simplicity

- Community activities based on teamwork, not individual competition (wagata)
- In general, withdrawal fees usually range from 0.3% to 10%, but W charges 0%
- Participants can join for as little as 1W (100 USDT) and earn a referral fee. Participants can also earn a royalty of 10 times the amount of their participation, with 10 times the amount earned for each additional level. Participants with 10W (1,000USDT) are also entitled to earn center fees for up to 20 levels, as well as the entire group's Level Achievement Fee
- W's royalty is innovatively enhanced  
The wealth redistribution is designed to be perpetual  
This technology will transform the future of finance and alleviate the wealth gap

# Three major features of the W equation



## Continuation

W is a 100% return circulation system as a new financial concept.

Spread royalties will be rotated every 1,000% of the participation fee.



## Peace of Mind

W is a rational decentralized autonomous organization (DAO)

- 1% centralized, 99% decentralized
- 40% at the DAO level, 59% at the network level
- 30% for referrals, 20% for the center, and 9% for fixed deposits



## Safety

W is a system in which the balance of funds is permanently stable. There are no overpayments of more than 100% and no small payments of less than 99%.



# W Roadmap

**July 30, 2022:**

After approximately six months of testing, the platform's safety has been verified.

The initiative began in 40 countries, including Germany, Dubai, Singapore, South Korea, Japan, India, Southeast Asia, Australia, Saudi Arabia, Brazil, Peru, Chile, and Mexico.

**March 2024:**

After reviewing system improvements and a high-efficiency loyalty method, the platform will relaunch.

**March 28, 2025:**

Global Payment System "Go" Released

**2025:**

Besides fixed deposits, business plans, including loyalty methods, will be announced.

**2025 ~ 2026:**

A WEB3-compatible wallet app is scheduled to be released.



# What is a DAO (Distributed Autonomous Organization)?

DAO is a term used to describe an organization that can promote a business or project without a specific owner or manager

Its official name is Decentralized Autonomous Organization, and the acronym DAO stands for Decentralized Autonomous Organization

DAOs are fundamentally different from conventional organizations such as joint-stock companies, and are attracting attention as a form of organization that will flourish in the era of Web 3.0

A famous example of a DAO is Bitcoin (BTC)

The Bitcoin blockchain network is maintained and managed by the mining activities of miners around the world, without a specific leader

As a result, the market capitalization of BTC has reached approximately 50 trillion yen, making it a successful project
